## Terms of Reference

### Eligibility

- ▶ Must be brand owners based in India
- ▶ Minimum Sales Quantity-2 lac fan either in the current financial year or the preceding financial year.
- ▶ Should be proposed & seconded by two existing Primary members

### Other Terms & Condition

If any such member crosses the figure of 10 lac volume sales in any subsequent year, then such a member would have to pay additional entrance membership of 1.50 lacs since it would be a part of the '3.00 lacs entrance membership bracket'.

Any change in the 'Brand' ownership also needs to be intimated to the EC and after a thorough review and discussion the EC would decide the continuation of such a Brand in question as an Associate Member.

In case a Brand owner acquires another brand with manufacturing set up, the status would remain the same for the both the Brands till the time the EC along with CII are convinced of all the legal perspectives and till that time both the Brand would continue to pay their respective membership charges.
